Notice of Extensions of Permits

Take notice that, in accordance with P.L. 2020, c. 53, concerning the extension of certain governmental permits, approvals, and deadlines during the public health emergency created by the COVID-19 emergency and supplementing Title 40 of the Revised Statutes, and subject to any exceptions contained therein, the running of the period of permit approvals granted by the New Jersey Sports and Exposition Authority, pursuant to P.L. 1968, c. 404 (N.J.S.A. 13:17-1 et seq.) and P.L. 2015, c. 19 (N.J.S.A. 5:10A-1 et seq.), in existence on March 9, 2020, is suspended for the COVID-19 extension period, which began on March 9, 2020, and shall continue for as long as the public health emergency that has been declared by the Governor in response to COVID-19, pursuant to the Emergency Health Powers Act, P.L. 2005, c. 222 (N.J.S.A. 26:13-1 et seq). The approval period for permit approvals granted by the New Jersey Sports and Exposition Authority, which, but for the extension, would have expired prior to the end of the COVID-19 extension period, shall be extended at least six months beyond the conclusion of the COVID-19 extension period. However, the holder of the extended permit must also report that extension to the New Jersey Department of Environmental Protection (NJDEP), which has been designated as the agency responsible for maintaining the list of all permits and approvals extended pursuant to P.L. 2020, c. 53. Holders of an approval asserted to be covered by the Act shall register such approval by providing information specified at www.nj.gov/dep/pea2020. The permit must be registered with the NJDEP within 30 days of the date of publication of the NJDEP notice published elsewhere in this issue of the New Jersey Register. The provisions of this notice shall also apply to approvals issued by designated opt-out municipalities for properties within the Hackensack Meadowlands District pursuant to P.L. 2015, c. 19 (N.J.S.A. 5:10A-1 et seq).

This notice is published in compliance with Section 5 of P.L. 2020, c. 53.
